

## HUSTLER CASINO LIVE PLAYER AGREEMENT

High Stakes Poker Productions, LLC (“High Stakes Poker”) hosts live-streamed poker events at Hustler Casino in Gardena, CA called Hustler Casino Live. In consideration of my participation in any Hustler Casino Live events (the “Events”), Undersigned Player (“Player”) hereby acknowledges and agrees to the following:

1. While participating in the Events, Player will not have with him or her at the poker table any electronic device of any type, including, but not limited to, cellphones, headphones, smart watches or ear pieces. Player may place any such items in duffel bags with high-shielding fabric, provided by High Stakes Poker, to prevent electronic transmission.

2. While participating in the Events, Player will not have with him or her at the poker table any bags of any type, including, but not limited to, backpacks, purses, or fanny packs. Player can place any such items in the high-shielding duffel bags provided by High Stakes Poker.

3. If Player puts items in the duffel bags provide by High Stakes Poker, he or she does so at his or her own risk. The duffel bags will be put in the corner of the playing room away from the poker table. High Stakes Poker is not responsible or liable for the loss, theft, or destruction of items that Player brings to the Events.

4. Player will not, under any circumstances, collude with, partner with, or become a teammate of another person participating in the Events.

5. Player will not (a) pay for or contribute to another person’s buy-in required to participate in the Events or (b) pay for or contribute to any other payment required by another person to participate in the Events.

6. Player will not engage in any form of “percent staking” with any other person participating in the Events.

7. Prior to, during, or after the Events, at High Stakes Poker’s discretion, Player permits High Stakes Poker employees, personnel, or agents to conduct metal-wanding searches of Player’s person, while Player is located at the Hustler Casino.

8. Player hereby gives his or her full and complete release permitting High Stakes Poker to video record, audio record, and photograph Player during the Events, and permits High Stakes Poker to use the video recordings, audio recordings and photographs for any legal purpose, including, but not limited to, live-streaming on the Internet. The rights, title, and interest in the video recordings, audio recordings, and photographs shall belong to High Stakes Poker, and Player shall not be entitled to any royalties or additional compensation related to the video recordings, audio recordings, and photographs should High Stakes Poker choose to exercise such rights.

9. If Player fails to abide by any provisions of this Agreement, High Stakes Poker is permitted and authorized to disqualify Player from the Events at any moment, and Player may

not be entitled to a payment of any money or poker chips won during the Events, and will not be entitled to a refund of any money or poker chips that Player lost during the Events.

10. At all times, Player plays at the Events at the sole discretion of High Stakes Poker and may be removed from games with or without cause at any time.

11. Player, and all other players, are chosen to play in Hustler Casino Live Events at the sole discretion of High Stakes Poker.

12. High Stakes Poker is not responsible to Player for the outcome of any Event or statements made about Player by other players or third parties.

13. This Agreement is in effect and binding on Player until High Stakes Poker requires Player to sign a revised version of the Agreement, or for a period of two (2) years after the signing of the Agreement, whichever date is earlier.
