**FELONY COMPLAINT
FOR ARREST WARRANT**

The undersigned is informed and believes that:

COUNT 1

On or about September 29, 2022, in the County of Los Angeles, the crime of GRAND THEFT, in violation of PENAL CODE SECTION 487(a), a Felony, was committed by BRYAN SAGBIGSAL, who did unlawfully steal, take, carry, lead, and drive away the personal property of RABIA LEW, specifically, poker chips, which had a value exceeding nine hundred fifty dollars (\$950).

COUNT 2

On or about September 29, 2022, in the County of Los Angeles, the crime of GRAND THEFT, in violation of PENAL CODE SECTION 487(a), a Felony, was committed by BRYAN SAGBIGSAL, who did unlawfully steal, take, carry, lead, and drive away the personal property of HUSTLER CASINO, specifically, \$5,000, which had a value exceeding nine hundred fifty dollars (\$950).

It is further alleged that prior to the commission of that offense or offenses alleged in Counts One and Two, the defendant, BRYAN SAGBIGSAL had been convicted of the following serious and/or violent felony , as defined in Penal Code section 667(d) and Penal Code section 1170.12(b), and is thus subject to sentencing pursuant to the provisions of Penal Code section 667(b)-(j) and Penal Code section 1170.12:

NOTICE: Prison custody time for the above offense is to be served in state prison based upon you having a prior conviction for a serious felony defined in Penal Code section 1192.7(c) and/or violent felony defined in Penal Code section 667.5(c), or a requirement to register as a sex offender pursuant to Chapter 5.5 (commencing with Penal Code section 290) of Title 9 of Part 1, within the meaning of Penal Code section 1170(h).

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.

Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR.

NOTICE: Any allegation making a defendant ineligible to serve a state prison sentence in the county jail shall not be subject to dismissal pursuant to Penal Code § 1385.

NOTICE: Conviction of this offense prohibits you from owning, purchasing, receiving, possessing, or having under your custody and control any firearms, and effective January 1, 2018, will require you to complete a Prohibited Persons Relinquishment Form ("PPR") pursuant to Penal Code § 29810.

Further, attached hereto and incorporated herein are official reports and documents of a law enforcement agency which the undersigned believes establish probable cause for the arrest of defendant(s) BRYAN SAGBIGSAL for the above-listed crimes.
